



The Tournament

Xpressbet's \$10,000 Thanksgiving Handicapping Tournament (the "Tournament") challenges players to successfully make twelve (12) 'live' Win bets (\$10 minimum) (the "Tournament Wager") on a list of twenty-five (25) specified eligible races that take place from November 28 to December 1, 2019 ("Tournament Days"). Customers may wager on more than one horse in each race and must place winning bets on twelve (12) of the twenty-five (25) Tournament Races to receive a share of the prize. The total amount wagered is at the discretion of the player.

Registration is free and is required to participate in the Tournament.

How To Enter:

- Participants must register for the Tournament by visiting www.xpressbet.com, logging into their account and selecting 'Register Now.' A 'Registration complete' message indicates a successful registration. If the customer receives an error message or encounters any other technical issue, such customer's registration will not be counted as complete.
- Participants must have an Xpressbet account in good standing, one (1) account per person, in order to participate.
- Customers may register any time during the Tournament, but must register before 11:59PM ET on Sunday, December 1, 2019, to qualify.
- Once a customer has successfully registered, the customer cannot opt-out the Tournament. Customers may unsubscribe from receiving certain types of emails by selecting 'Unsubscribe' at the bottom of any email sent by Xpressbet and following the instructions and prompts.

How to Play:

To compete, registered players must make twelve (12) online, "live" Win wagers (\$10 minimum) on a series of twenty-five (25) eligible races on November 28, November 29, November 30 and December 1, 2019. Eligible races will be specified on the Contest website no later than November 23, 2019. All players that place twelve winning wagers will receive an equal split of the \$10,000 prize. Registered players do not need to wager on all twenty-five races, however, they must make "live" Win bets (\$10 minimum) on the winners of at least twelve Tournament races to qualify. Players may wager on multiple horses in each contest race. Total amount wagered is at the discretion of the player. Any Win bet below the contest minimum of \$10 is not eligible for the Tournament. Win bets equal to or exceeding \$10 are eligible. Wager minimums and wager rules are at the discretion of each racetrack and its regulators.

Registered players may place wagers using their online Xpressbet wagering account, Xpressbet Mobile, Xpressbet Platinum Teller Service or Xpressbet Voice & Touch Tone Service.

Canceled wagers will not count in the Tournament. Refunded or partially refunded wagers are handled at the discretion of the host racetrack and its governing bodies.

How To Win



- The winner of the Tournament will be selected from Tournament wagers placed by registered participants received during the Tournament period. Winner(s) will be determined solely based upon whether they placed Win bets (\$10 minimum) and correctly selected the winner of at least twelve (12) eligible races. Winner(s) will be determined by Xpressbet Management, whose decisions are final and binding in all respects.
- Odds of winning are determined by the number of eligible entries received for the Tournament.
- Ties:
 - In the event of a tie, the total prize will be evenly divided among all eligible players.
- All Decisions are final.
- Prizes may not be substituted, transferred or assigned by participants. Prize winners will be notified via email by 5:00PM Eastern Time on Wednesday, December 4, 2019.
- Prizes will be awarded as soon as winner qualification is verified.

Prizes

- All winning players will receive an equal share of \$10,000.

Things You Should Know

- Player wagering accounts will be credited with winnings for all Tournament wagers and debited for all losing wagers.
- Entries must be made in accordance with these Official Rules; any other attempted form of entry will NOT be accepted.
- Any use of robotic, automatic, macro, programmed or like call-in or registration entry or wager methods will void all such entries and result in disqualification.
- Results for the competition will be posted on the Xpressbet website www.xpressbet.com, and winners notified by 5:00 PM Eastern Time by Wednesday, November 4, 2019.

To Establish an Xpressbet Account

Xpressbet applications are accepted online at www.xpressbet.com; by calling toll-free (866) 889-7737; or in-person at an Xpressbet center at any one of the following race tracks or wagering facilities: Gulfstream Park (Hallandale Beach, FL), Golden Gate Fields (Albany, CA), Laurel Park (Laurel, MD), Pimlico Race Course (Baltimore, MD), Portland Meadows (Portland, OR), Santa Anita Park (Arcadia, CA), Suffolk Downs (East Boston, MA), The Meadows (Meadowlands, PA), The Meadows OTB - Harmar (Pittsburgh, PA), Hawthorne Race Course (Cicero, IL), Club Hawthorne OTB – Bloomington-Normal (Bloomington, IL), Club Hawthorne OTB – Bolingbrook (Bolingbrook, IL), Club Hawthorne OTB – Chicago-Corliss Avenue (Chicago, IL), Club Hawthorne OTB – Glendale Heights (Glendale Heights, IL), Club Hawthorne OTB – Joliet (Joliet, IL), Club Hawthorne OTB – Mokena (Mokena, IL), Club Hawthorne OTB – Prospect Heights (Prospect Heights, IL) and Thistledown (Cleveland, OH). Locations are subject to be added or removed, so please contact Xpressbet Customer Service at (866) 889-7737 for the most current list. Follow all instructions, first providing your name, complete residential address (including zip code), telephone number, date of birth, social security number, drivers license number and state, email address and mailing address (if different from residential address). You will also be asked if you wish to receive email updates about Xpressbet, LLC; you may complete and submit the application (and register for the Tournament) without consenting to receive such email updates. If submitting an application online, indicate your preference by either retaining or removing the checkmark from the designated box. Then, select a username and password, security question and answer, and PIN and account password for your Xpressbet account. Upon completion of these steps, and valid identity check, you will be assigned a unique Xpressbet account number. As part of the application procedure, you may then also activate your Xpressbet account for wagering by depositing funds into the account. Once the application procedure has been completed and your Xpressbet account has been established, you may register for the Tournament by following instructions located on the home page of the Xpressbet website located at www.xpressbet.com.



Taxes

Liability for any and all federal, state and local taxes rests solely with the prize winner.
